## General terms of contract and trade:

### §1 Legal basis

The World Intellectual Property Organization (Wipo) has been published the International Patent Application. The publishing forms the basis of our offer. Accepting the offer your International Patent Application, and/or company-referring data of the patent application older is stored.

### §2 Purpose of the registration:

The purpose of the registration is for one thing to be able to obtain fast information about foreign claims for international patent applications as well as their holders by the access to our data files. So you can eventually improve your position in competition. Secondly, it is the purpose of registration to improve eventually your communication possibilities in competition. To fulfill this task or make it easier our data banks which are enlarged, actualized, and eventually also modified from day to day with international patent applications besides entries about their holders are at your disposal. The entitled to benefit person has -in principle- cost-free access to our data bases. This is not only the case for our data bases in the context of european published patent applications, european patents, German published patent applications, and German granted patents, registered utility model, and new registrations of German companies.

### §3 Legal note for the user I:

The publication in the International Patent Applications reports (name, postal data, and reference data) is electronically recorded in accordance with § 26 German Law about data protection, and stored. Accepting our offer, and with your registration as an entitled person to benefit person to benefit from the services of WIHH, you have besides the mere collecting of data the possibility to take cost-free advantage of all services of WIHH.
